Media: 2 Dimensional Art: Acrylic, Oil, Digital Art, Drawing/Pastel, Mixed Media, Collage, Photography, Watercolor, and Colored Pencil

Eligibility: Open to all artists 18 years and older. All work must be for sale. Work must be original and executed in the past two years. A maximum of (3) works may be submitted, and a maximum of (2) works may be selected. Work must not have been exhibited in previous Sampson Arts Council Juried Art Exhibitions.

Requirements for Entries: Participants must submit a CD or USB flash drive with a maximum of three (3) entries, which must be completely original by the artist. Images will be reviewed by the judge, and artists will be notified of entries chosen. Maximum of (2).

Entry Fee: \$25.00

Entry due date: November 27, 2018

Digital size limitations: TIFF 300dpi and 1800 pixels (longest side) recommended.

Label images: last name, first name, and # corresponding to entry # (i.e. Doe_John_03.jpg) do not imbed any information on the image file itself, such as name, copyright, logo, etc. to keep judging anonymous.

General Information

Notification of Acceptance: Entrants will be notified via email of their acceptance into the exhibit on or about December 11, 2018.

Due to limited space, art must not exceed 48" (including frame) in any dimension or weigh more than 50 lbs. All work must be framed, wired (no saw-tooth hangers) and ready for hanging or it will not be accepted. The Sampson Arts Council reserves the right to reject any entry that requires special installation or care.
